

POLLSTAR LIVE! 2019 POSTER CONTEST

(The “Contest”)

OFFICIAL RULES

**NO PURCHASE NECESSARY. VOID WHERE PROHIBITED.
A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.**

1. **PERIOD:** Contest begins at 12:00 p.m. Pacific Daylight Time (“PDT”) on September 14, 2018 and ends at 11:59 p.m. PDT on January 4, 2019 (the “Contest Period”).

2. **ELIGIBILITY:** Contest is open to legal U.S. residents who are, or are a representative of, a promoter, manager or similar position of (a) live event(s) and/or show(s) in the 2018 calendar year and who are at least 18 years old at time of entry. Contest is void where prohibited by law. Directors, employees, and the immediate family (spouse, parent, sibling, children, grandparent or grandchildren and their respective spouses, regardless of where they reside) and/or household members, whether or not related, of individuals employed by OVG Media & Conferences, LLC, (“Sponsor”), and all of their respective parents, subsidiaries, affiliates, directors, officers, employees, advertising and promotional agencies, are ineligible to participate. Contest is subject to all applicable federal, state and local laws.

3. **HOW TO ENTER:** Submit your wholly original artwork to: Oak View Group (Poster Contest) 1100 Glendon Ave, Suite 1250, Los Angeles, CA 90024, Attn: Media & Conferences. To be considered for the Contest, each submission (“Contest Submission”) must be received no later than January 4, 2019 and:

- Must showcase a live event and/or show that you produced in the 2018 calendar year.
- Posters must be unmounted and no larger than 24” x 36”.
- Must be shipped unfolded in a tube or flat – NO FOLDED CONTEST SUBMISSIONS.
- Must include contact information consisting of your name, email address, phone number, and address.
- A 72 dpi jpeg or png file of your submission must also be sent to:

Sponsor reserves the right to allow for minor deviations from the guidelines and restrictions set forth herein, based on clear intent to comply with these Official Rules, as determined by Sponsor in its sole discretion. All Contest Submissions become the sole property of the Sponsor and will not be returned.

PROHIBITED CONTENT: Contest Submissions may not contain, as determined by the Sponsor, in its sole discretion, any content that:

- is sexually explicit or suggestive; unnecessarily violent or derogatory of any ethnic, racial, gender, religious, professional or age group; profane or pornographic; contains nudity;
- promotes alcohol, illegal drugs, tobacco, firearms/weapons (or the use of any of the foregoing); promotes any activities that may appear unsafe or dangerous; promotes any particular political agenda or message;
- is obscene or offensive; endorses any form of hate or hate group;
- appears to duplicate any other submitted Contest Submission;

- defames, misrepresents or contains disparaging remarks about Sponsor, its products or services, other people or companies;
- contains trademarks, logos, or trade dress (such as distinctive packaging or building exteriors/interiors) owned by others, without permission, to the extent permission is necessary;
- contains copyrighted materials owned by others (including music, photographs, sculptures, paintings, and other works of art or images published on or in websites, television, movies or other media), without permission, to the extent permission is necessary;
- contains materials embodying the names, likenesses, voices, or other indicia identifying any person (living or dead), such as license plate numbers, personal names, e-mail addresses or street addresses, including, without limitation, celebrities and/or other public or private figures, living or dead, without permission, to the extent permission is necessary;
- communicates messages or images inconsistent with the positive images and/or good will with which Sponsor wishes to associate; and/or
- violates any law.

By submitting a Contest Submission, entrant represents and warrants that the Contest Submission conforms to these Official Rules and understands that Sponsor, in its sole discretion, may disqualify the Contest Submission for any reason, including if it determines, in its sole discretion, that the Contest Submission fails to conform to these Official Rules in any way or otherwise contains unacceptable content as determined by Sponsor, in its sole discretion.

USE OF CONTEST SUBMISSIONS: By submitting a Contest Submission, entrant hereby grants to Sponsor a nonexclusive license to reproduce, distribute, display, perform, create derivative works based upon, or otherwise exploit the Contest Submission in any manner or media now known or hereafter devised throughout the world in perpetuity for advertising, promotional and other purposes, without further compensation, notification or permission. Entrant agrees that Released Parties (as defined below) are not responsible for any unauthorized use of Contest Submissions by third parties. Sponsor has no obligation to make use of the rights granted herein.

4. WINNER DETERMINATION:

All eligible Contest Submissions will be judged in accordance with the following criteria: (i) Content; (ii) Creativity; (iii) Originality; and (iv) Public votes from the Pollstar Live! 2019 Conference. A panel of qualified judges will do a preliminary screening of all entries on January 11, 2019 for compliance with the rules and adherence to the judging criteria, as well as hand selecting Contest Submissions to advance to the public round. Such judges shall determine adherence to the judging criteria in their absolute and sole discretion. Sponsor shall display a to-be-determined number of Contest Submissions with the highest scores at the Pollstar Live! 2019 conference for voting by the attendees of the Conference ("Attendees").

Each Attendee may cast one vote for one Contest Submission at the Pollstar Live! 2019 conference. The winners of the Contest will be determined based upon the number of qualifying votes received. Any attempt by any person to vote more than the number of times authorized herein, using any third-party proxy voting services, using multiple names or e-mail addresses and/or any other fraudulent mechanism(s), including robotic, automatic, programmed or similar methods, shall give Sponsor, in its sole discretion, the right to disqualify the vote and/or Contest Submission from Contest. All Contest Submissions and the votes each Contest Submission receives are subject to verification by Sponsor, and must meet all eligibility requirements before Contest Submission may be confirmed as a winner of any prize

The three (3) Contest Submissions that receive the overall highest scores shall be deemed the winners (together, the "Potential Winner"). In the event of a tie, Contest Submissions will be re-judged based on the same criteria listed above and a winner will be determined by Sponsor in its sole discretion. Decisions of Sponsor and judges are final and binding.

THIRD PRIZE (1): One (1) First Prize Winner will receive one (1) third-page, full color advertisement in Pollstar (Approximate Retail Value (ARV): \$899).
